- Videography of each meeting/ election of society is mandatory.
- Collegium Scheme to be approved from District Registrar if members strength is more than 1000.
- Administrator if appointed will not enroll new members, incur capital expenditure and give employement in the society
- Terms of Governing Body not to be more than 3 years.
- Member to be not less than 21 year age.
- Office bearers of society (Three to twenty one).
- General Body and other meeting should be conducted with quorum i.e 1st meeting 40%, 2nd meeting 25% and 3rd meeting -(see entire Provisions)
- Submission of mandatory Annual Returns i.e. list of members, list of members of collegium, list of affice bearers, Annual Report on working, Balance Sheet & Auditors Report, Copy of special resolution otherwise shall attract penalities & fines as per
- In case of Joint Apartment owners, 1st owner will be eligible to contest the elections.
- · Proxy voting not allowed.
- Condominium/ Association covered under Apartment Ownership Act 1983 is to be formed by owners only.
- · Election observer may be appointed by District Registrar or on request of Society
